Terms and Conditions

1. Deposit A non-refundable deposit of £100.00 should be returned to the Club with your Booking Form within 14 days of making a booking. If this is not received the Club reserves the right to release the booking without notice. Once a deposit has been received by the Club no refund can be given should cancellation be necessary.

2. Confirmation The Organiser must confirm to the Club precise numbers at least 48 hours prior to the date of the booking. Confirmed numbers will be charged for in full.

3. Changes in Numbers If the Organiser wishes to increase the number of places then, subject to availability, the club shall make such places available. When provisionally booking a number of guests for a golf day and the numbers drop dramatically or by more than 8, you will be charged accordingly unless we are aware of this reduction at least 14 days prior.

4. Cancellation In the event of cancellation by an organiser within 1 month of the booked date 75% of the anticipated attendance will be payable.

The Club reserves the right to cancel or amend any reservations. If inclement weather prevents the playing of Golf the Club will refund any deposit made in respect of Golf, but will have no further liability to the Client. If the Club is forced to cancel an event for reasons beyond its control, refunds will be considered in accordance with prevailing Consumer Rights law.

5. Damage The Client in accepting these Terms & Conditions assumes responsibility for any and all damage caused by him or any member of his party whether in the Clubhouse or on the Golf Course.

6. Personal Property The Club shall not be liable for loss of or any damage to the property of the Client or any of his/her guests suffered or incurred whilst on the Club premises including personal belongings.

7. Variation These Terms and Conditions cannot be varied or altered by any member of staff unless confirmed in writing by the Management of the Club.

8. Slow Play Rounds of over 4 hours are unacceptable and will detract from the day's enjoyment for all players. Therefore, it is the organiser's responsibility to choose formats that encourage continuous play.

Stableford Competitions are much more enjoyable than stroke play. Four ball medals must not be played. For Societies playing 36 Holes it is recommended that at least one round is a Foursome or Greensomes.

Your reserved Tee times and meal times are pre- arranged and therefore it is essential that these are strictly adhered to.

9. Handicaps All visitors to the course should ideally hold current handicap. However if any of your party do not hold a handicap you are reminded that each person should show a competent level of play and be aware of the rules of golf and course etiquette.

10. Account Final numbers must be confirmed two days prior to the event. These will be the final numbers charged for.

Full payment to be made on the day prior to play.

The Front of House Manager is to be advised in advance if you wish to run a Bar Account.

11. Dress Code and Etiquette Please ensure that all your members are advised of the following:

Members of your society must play with their own set of clubs, proper golf footwear must be worn and you are expected to know and abide by the etiquette & courtesy of a members' Golf Club.

Casual wear is permitted in the Lounge/Dining Area and Bar. Jeans, T-shirt's, Trainers and other unsuitable attire is not allowed in the Clubhouse or on the Golf Course. Shirts must have collars and be tucked in.

Societies must use the visitors changing room and not the member's locker room (if applicable)

Shoes must not be changed in the car park

12. Covid 19 Statement COVID-19 has been declared as a worldwide pandemic by World Health Organization. The government and federal health organisation have implemented social distancing measures to prohibit the congregation of large groups of people. ORIDA Golf and Leisure have put in place preventative measures to reduce the spread of COVID- 19, however take no liability if the Client or his/her guests contract the virus. We advise all clients to ensure that they arrange adequate insurance cover prior to their event visit. If the Client's event is directly affected by COVID-19 please refer to our *Clause 8 Cancellation by the Club*.

13. Notice The Client shall provide accurate information, in a timely manner to the Club. Any messages the Club receive whether via phone or email, regardless of business hours, are not considered confirmed until you have received confirmation from our Events Team.
